In the Name of God Amen I Jacob Doré of Winchmore Hill in the Parish of Edmonton in the County of Middlesex Gentleman formerly of Cork Lane in the Parish of Saint Matthew Bethnal Green in the County aforesaid being sick and weak in body but of sound and perfect memory and understanding do make publish and declare this my last Will and Testament in manner and form as follows (viz) First of all I do give devise and bequeath unto my beloved Wife Magdalen Theresa Dore my dwelling house which I now do live in together with all my Freehold Estate viz the Field Gardens out offices and all the appurtenances belonging to the said Freehold Estate situate and being at Winchmore aforesaid to have and to hold the same for and during the term of her natural life (subject to be upheld and kept in tenantable repair) and after the decease of my said Wife I do give bequeath and devise my aforesaid Freehold Estate with all the appurtenances belonging to the same unto my cousin John Levesque of Hoxton Town in the County of Middlesex Stock Broker his Heirs Executors Administrators and Assigns also I do give and bequeath unto my aforesaid Wife all my household furniture plate linen china and wearing apparell of what kind soever and wheresoever for her sole use and benefit forever also I do give and bequeath unto my uncle Peter Levesque the sum of five pounds sterling money of Great Britain also I do give and bequeath unto my cousin John Levesque aforesaid the sum of five pounds sterling also I do give and bequeath unto Magdalen Levesque the wife of the aforesaid John Levesque the sum of five pounds sterling also I do give and bequeath unto Ann Levesque the daughter of John Levesque aforesaid the sum of five pounds sterling also I do give and bequeath unto Mary Levesque the daughter of the aforesaid John Levesque the sum of five pounds sterling also I give and bequeath unto my uncle **Daniel Dore** one shilling and all the rest residue and remainder of my worldly goods money effects and property whatsoever and wheresoever and of what kind soever (after all my just debts and Funeral expenses are paid) I do give devise and bequeath unto my beloved Wife (aforesaid) Magdalen Theresa Dore and I do hereby nominate and appoint my beloved Wife Magdalen Theresa Dore my Executrix and Mr William Hammond surgeon of Southgate in the Parish of Edmonton and County aforesaid my Executor of this my last Will and Testament hereby revoking all former Will and Wills by me heretofore made and do declare this to be my last Will and Testament. In witness whereof I have hereunto set my hand and seal this nineteenth day of February in the year of our Lord one thousand seven hundred and ninety. Jacob Dore. Signed sealed published and declared by the aforesaid Jacob Dore as for his last Will and Testament in the presence of us who have hereunto subscribed our names as witnesses thereto in the presence of the said Testator and in the presence of each other. This Will was proved at London on the nineteenth day of August in the year of our Lord one thousand seven hundred and ninety before the Worshipful George Harris Doctor of Laws and Surrogate of the Right Honourable Sir William Wynne Knight Doctor of Laws and Master Keeper or Commissary of the Prerogative Court of Canterbury lawfully constituted by the oaths of Magdalen Theresa Dore Widow the Relict of the deceased and William Hammond the Executors named in the said Will to whom administration was granted of all and singular the goods chattels and credits of the said deceased having been first sworn duly to admon.
